It was Omicron Zeta who pushed the national fraternity to drop its restrictive membership clauses, and it was Lambda Chi Alpha who eliminated abusive pledging long before hazing was in the national spotlight.



A Thriving Chapter

Our undergraduate chapter continues to grow, putting the squeeze on accommodations at the house. But the quality of the chapter is as strong as ever. Lambda Chi Alpha's average GPA stands at 3.34, above the fraternity average of 3.29.

The chapter enjoys a good social position, and high visibility with many brothers serving on the boards of the IFC, The Cornell Tradition, and the Meinig Family Scholars among many sports teams, honor societies, and clubs. The intramural program is also strong, with a soccer championship in hand and a shot at the All-Sports Trophy for the first time since 1949.

The brothers bring their passion to the community, lending a hand to the Cornell Plantations, as well as the Ithaca community through the North American Food Drive. But what drives them is their bond with each other, and love for Lambda Chi.

The Campaign

The need to renew our historic home is clear. The Campaign Executive Committee, appointed by ISWZA, has been laying the groundwork for several years to ensure a successful fundraising campaign and house renovation—one which is estimated to cost **\$2.4 million**.

The Campaign Committee consulted with the undergrads on their needs, and toured recently renovated Cornell fraternity houses and met with their alumni. Greg McElroy, a professional fraternity fundraising consultant, was engaged to assist.

In 2011, the Edgemoor Leadership Foundation was created to fund education and leadership programs. ELF is a 501(c)(3) charitable organization, and can receive tax-deductible gifts.

With the assistance of McElroy & Associates, we successfully completed a feasibility study confirming that our goals were realistic. Cornell University approved this study, clearing the way for contributors to the Campaign for Omicron Zeta to receive credit toward university giving societies and class recognitions.

Philip B. Prigmore '69 O-1065, an Alfred-based architect specializing in historic preservation and design, has been an invaluable resource. His firm, JHL Tecture, was selected for PDM work.

Finally, the Campaign was formally announced on October 19, 2013 at the Omicron Zeta Centennial Celebration. The foundation is laid; now it is up to all of us to make our fraternity's dream home a reality.

Edgemoor Leadership Foundation

Our 501(c)(3) foundation

The Edgemoor Leadership Foundation (ELF) was created in the fall of 2011 to improve the education and leadership experiences and achievements of Omicron's undergraduate members. It also provides our alumni, parents, and friends a way to make IRS-approved 501(c)(3) **tax-deductible donations**.

ELF's funds can be used to help renovate the house and add top-notch educational space for study and research. ELF can fund learning events that could include outside experts, alumni, and internet-based courses, seminars and conferences. ELF can also provide scholarships and grants for books, tutors and trips to leadership training programs.

Campaign contributions to ELF are not mandatory; your personal tax situation (or desire to fund quality education) will dictate if ELF is your preferred way to donate to Omicron's future. ELF exists to serve the students and alums, lighting the way to a bright 21st century—a journey that is just now getting started.

Edgemoor: Our Home

Over a century ago there was a group, a rollicking band of inseparable friends. Outsiders called them Mug & Jug, a name they embraced. With graduation approaching, they wanted to see this same friendship continue at school and beyond, and they organized themselves as a fraternity. The master stein that provided an evening's beer would provide them a name as well: ISWZA, from the German drinking song whose lyrics adorned it, *Im Schwarzen Walfisch Zu Askalon*.

“Strengthen the Fraternal Bonds”

From the start, the members of ISWZA sought to live together, sharing rooms for a year, then able to rent a whole house starting in 1909. Just a few years later, we bought a house of our own at 614 Stewart Avenue.

On October 11, 1913, ISWZA became Omicron Zeta, the twelfth chapter of the growing national fraternity Lambda Chi Alpha. We were the first chapter to own our own house and take our meals together, “a practice which cannot but help to strengthen the fraternal bonds and fellowship of the members” in the words of the national correspondent.

Omicron speedily outgrew that house, and in 1921 purchased a house at 125 Edgemoor Lane, which was being vacated by Phi Delta Theta. We have remained ever since. ISWZA adopted the name “Edgemoor” for the house in 2013.



It is the home we found in Ithaca, the base from which we set off into the world, and to which we return again. It is where we formed lifelong friendships, developed our social lives, and learned how to become leaders. It is where our little brothers now follow in our footsteps.

This house is our legacy to future generations of Lambda Chi Alpha at Cornell.

An Aging Facility

But despite the efforts of alumni and undergraduates alike, a century of wear and tear is manifest. The house is woefully energy-inefficient. The electrical and plumbing are outdated and inadequate. Standards are rising, as they should, but incremental improvements are becoming more frequent and more costly with each passing year.

Edgemoor in '21: One of Cornell's Finest Fraternity Lodges

The *Omicron Alumni News* deemed our "splendid new home" to be "one of the finest fraternity lodges" at Cornell.

The first floor is so arranged as to rank high from a utilitarian standpoint, but it also provides that which Omicron has long wanted, an adequate place in which to hold dances and other social entertainments.... The rooms are connected by broad arched doorways, so that the entire floor may be thrown open for dancing....

The dining-room presents a very home-like appearance with its dark woodwork, paneled ceiling, and cheery lights.... Dormitories, in which all of the men sleep, are on the second and third floors, in an addition built this summer directly over the dining-room.... This has given Omicron more space for studies, and makes possible the accommodation with ease of forty-five men.

Edgemoor in the 21st Century: Time for Renewal

Our house is aging, with many outdated systems and ever-rising maintenance costs. But there are issues even more fundamental.

Based on focus groups with our current active brothers, and an in-depth survey of current and recent undergraduates, and alumni tours of other recently renovated fraternities on the Cornell campus, it is clearly evident that the ideal fraternity house for the 21st century is quite different from the one most of us remember from our days on The Hill.

Today's Cornell students have grown up differently, and want to live differently during their college years. Dormitory sleeping arrangements a long time ago became a thing of the past. Today's most desired features are comfortable suite-style living areas with upgraded technical and communications infrastructures where students both study and sleep.

Other desired features include large study rooms, like the Reading Room at Willard Straight Hall we remember; a well-equipped exercise room, to help the men stay fit during Ithaca's long winters; and a more flexible dining room and kitchen, providing more on-demand eating options to fit the on-the-go, all-hours lifestyle of today's students.

Many competing houses have already undergone multimillion-dollar renovations. In Collegetown, rows of new amenity-rich high-rise apartments have turned the streets into Manhattan-like canyons. And the University's residential colleges, offering every modern convenience, have expanded across the campus.

To keep our little brothers well-sheltered, to continue to attract the finest members, and to maintain our leadership position on campus, Lambda Chi Alpha needs to renew our historic home.



Edgemoor's Future

Edgemoor is well into its second century, and it's been showing its age for many years. We want to bring it up-to-date— but without sacrificing its century-old charm and elegance. This calls for a committed response from our alumni brothers to ensure that ΛXA continues our leadership role on campus in our historic house. The Campaign Committee has approved a substantial restoration and expansion project which is estimated to cost \$2.4 million.

Restoration of the Grand Staircase and First Floor Expansion

It is time to restore our entrance to the original elegance we see above. Modern technology, the addition of new fire stairs, and the presence of fire sprinklers will allow us to open up our encased stairwell and add a more dignified replacement. This will also expand the depth of the foyer, restoring the sight lines from the east wing to the west wing of the house.

Over the dining room, an expansion will add two new rooms: an **Electronic Learning Center** and a new reading

room behind the stairwell. The Electronic Learning Center, built to parallel the Chapter Room both in size and in style, will serve as an elegant student salon.

The **Reading Room's** two-story ceiling and tall windows will make it an airy study lounge. It will be connected to both wings of the house, allowing it to be used for overflow. To the rear of the house, doors will open onto a new patio overlooking Cascadilla Gorge, connected to fire stairs that exit to the rear of the property.

Edgemoor's Future *(cont'd)*



New Rooms and Fitness Center

The new grand staircase will continue all the way up to the third floor. Construction of an expansion over the dining room will enable the addition of 4–6 new study/living rooms on the upper levels of the house.

The renovated house will include new heating, electrical, plumbing, and communications systems, making the house a more pleasant and usable place, with adequate electrical outlets, functional Internet access, and new bathrooms. Improved windows and insulation will make the house more efficient as well as more livable during Ithaca's winters.

To accommodate the staircase, the bathrooms will be relocated to their pre-1956 location in the east of the house. Adding a second bathroom on the third floor is also being considered.

In focus groups with undergraduates, the weight room was cited as very important to the brothers— as was its light, airy third floor location. The “Dormer Gym” currently occupies the space of the old third floor dorm, which of course was not designed for this use. To replace it, a new **Fitness Center** facility would be built on the third floor, allowing the conversion of the dorm to additional study/living rooms.

Two new fire stairs, one on each wing of the house, will add safety and utility for the residents, providing direct access to the rear of the property.


